**RE:** Conference call of February 1, 2008

On February 1, 2008, Commission Staff members Anita Mitchell and Jeff Shaw conducted a conference call with J. Gregory Cornett, the attorney of record for Louisville Gas and Electric ("LG&E"), to discuss issues related to LG&E's request to cease filing its FERC Form 2 report with the Commission. The purpose of the call was to allow Staff to convey to LG&E what Staff believed LG&E could file, in lieu of FERC Form 2, that would satisfy the Commission's information needs.

Staff indicated that it believed the information needs of the Commission would be satisfied by LG&E continuing to file (1) the annual report it currently files electronically and (2) the notes to its financial statements that it had filed with its FERC Form 2 report. Due to limitations in the Commission's electronic filing system, the notes to the financial statements must be filed in hard copy, so Staff suggested that the notes be filed along with a hard copy of the electronic report. Mr. Cornett stated that he needed to discuss Staff's suggestion with other LG&E personnel before he could respond. Mr. Cornett left a voice-mail message later that day stating that Staff's proposal was satisfactory to LG&E. He also reiterated LG&E's hope that an Order granting its request to cease filing its FERC Form 2 could be issued by mid February.

The call ended with the understanding that Staff would make its best efforts to see that an order on the issue at hand is issued in the time frame requested by LG&E. Staff also indicated that a memorandum summarizing the conference call would be prepared and filed in the record of this case.
