Dear Mr. King:

The Commission acknowledges receipt of your January 11, 2008 letter giving notice that the above-referenced utilities intend to file, either jointly or separately, an application for approval of retail tariff riders and revised tariffs, including environmental surcharge riders.

Each of the above-referenced utilities previously provided written notice of its intent to file an application for approval of an environmental surcharge rider, and the following case numbers were assigned:

Jackson Purchase, Case No. 2008-00010

Kenergy, Case No. 2008-00009

Meade County, Case No. 2007-00470

Since the applications for the newly noticed retail tariff riders and revised tariffs will be combined with the previously noticed applications for environmental surcharge riders, we believe that it will be more efficient for one application to be filed for each utility, rather than one application for all three utilities. This is based upon consideration of the number and complexity of the issues to be presented. Thus, each of the three utilities should file its application under the respective case number previously assigned. After the applications have been filed, consideration will be given to consolidation of the cases for purposes of review.
