NOTICE

Oldham County Water District proposes to revise its rate schedule to permit a customer to pay his or her bill for water service by credit card or debit card. Any person who uses his or her credit card or debit card to pay for service shall be assessed a non-recurring charge equal to the cost incurred to the utility to process the transaction. The proposed effective date for these revisions is March 1, 2008.

The fees contained in this notice are the fees proposed by the Oldham County Water District. However, the Public Service Commission may order fees to be charged that differ from these proposed fees. Such action may result in fee for consumers other than those in this notice.

Any corporation, association, body politic, or person may, by motion within thirty (30) days after publication of this fee change, request leave to intervene; and the motion shall be submitted to the Public Service Commission, 211 Sower Boulevard, Post Office Box 615, Frankfort KY 40602 and shall set forth the grounds for the request including the status and interest of the party.

Intervenors may obtain copies of the application and related filings by contacting the District.

The District has available for inspection at its office the proposed changes to the Rules and Regulations. The District office is located at 3701 W. Highway 146, LaGrange, Kentucky 40031.


Credit/Debit Card Policy

Payments using Credit or Debit card. All customers may pay their bill by credit or debit card. This method of payment may be made in person at the Oldham County Water District office or by telephone. If on the bill due date an attempt to pay by credit card or debit card is made and the card is declined for any reason, payment is still due in full on that date and will be considered late after that date. All late charges and penalties will be applied. If a customer is paying on our disconnect day and the card is denied, the same rules as above apply with the addition that his/her service may be disconnected.

When a customer makes a payment by credit or debit card, the utility will assess a fee equal to that charged to the utility by the credit or debit card processing company to process the transaction. This fee is generally calculated using a formula applied to the balance of the amount charge to the credit or debit card account but may be a flat fee per transaction. Prior to processing the transaction, the customer will be informed of the fee amount and, upon request by the customer, the formula employed to arrive at this fee amount.
