
On May 14, 2008, the Attorney General filed a motion to disqualify Commissioner Caroline Pitt Clark ("Commissioner Clark") from participating in this matter. On June 2, 2008, Commissioner Clark resigned from her position with the Commission. Given that Commissioner Clark is no longer with the Commission and, therefore, will no longer be able to review pending cases, the Attorney General's motion for her disqualification is now moot and will be denied.

Having considered the motion and being otherwise sufficiently advised, the Commission HEREBY ORDERS that the Attorney General's motion for disqualification of Commissioner Clark is denied as moot.
