# SUBJECT: Response to Letter of Deficiencies - Case 2008-00074 Letter Dated March 6, 2008

Dear Director O'Donnell,

In response to the above case and deficiency letter, we are providing 10 copies of the enclosed information;

807 KAR 5:001 Section 11(1)(a) - Statement of original cost of applicant's property (The applicant has filed a complete water fixed asset depreciation schedule with rate case 2006-00410. Its Ft. Knox sanitary and storm sewer assets and property were transferred to the District for \$1 each in 2005. See case no. 2004-00422. The new Radeliff sanitary sewer system assets will also be transferred to the District for \$1).

807 KAR 5:001 Section 6(4) Not Applicable (The applicant does not have any current mortgages)

807 KAR 5:001 Section 6(5) Current Bond information is provided as attached

807 KAR 5:001 Section 6(7) Not Applicable (The applicant has no other indebtedness)

In addition to this information, the District also submits;

<u>1. Request for Deviation</u>: The District (applicant) also requests a deviation from 807 KAR 5:001, Section 6, which requires that the applicant file financial exhibits covering the previous 12 months of operations, which information is no more than 90 days old prior to the filing date. The District is still preparing its year end, 2007 financial report and audit, and this information is not yet available. The most recent, audited, financial information would be from fiscal year 2006. The District submits that this information should still be relied on when reviewing or considering its existing bonds, and requests deviation to use the 2006 information as the latest financial information available. The District has submitted its 2006 Annual Financial Report to the Commission, which should be on record.

<u>2. KIA Debt Assumption Approval:</u> On March 6, 2007, the Board of the Kentucky Infrastructure voted to approve the District assuming the City's A97-03 revolving loan and present an Assumption Agreement to the District (See paragraph 7 with original application). The approval is contingent on PSC approval of the system transfer, and the District fully funding the replacement fund, which requires one additional

deposit of about \$30,000. As soon as the District receives the agreement and letter of approval, which is expected at any day, it will be forwarded to the Commission as part of this case record.

3. Revised Tariff Effective Date: We are also re-filing our proposed tariff with an effective date of April 13, 2008. The District also modified Sheet 5-41, Section 17-21, to strike a higher tap processing fee for outside City customers, to there is no distinction in the fee between an inside City or outside. We have continued to meet with the effected employees, and Veolia has made employment offers to each. Several factors are date sensitive, including retirement applications for some employees. We still request that the PSC provide an expedited review, with an approval date of April 13, so that the employees can proceed with their new employment plans, and do not have to re-apply or renew pre-employment information with Veolia.
