<u>ORDER</u>

An informal conference was held in this matter on July 31, 2008. At the conclusion of the conference, no resolution had been reached between the Applicant and the Intervenors regarding the Intervenors' objections to the construction of the proposed cell tower.

To ensure that this case continues to move forward in a timely manner, the Commission finds that Tracy Sullivan Sears and the Edith Sullivan Life Estate should state, in writing, whether they intend to remain as Intervenors in this proceeding. The Commission also finds that the Intervenors should state whether they intend to appear at a hearing on the application and whether they intend to present evidence in opposition to the proposed tower.¹ The Intervenors' responses will be due no later than 10 days from the date of this Order.

¹ If the Intervenors intend to present evidence in opposition to the proposed cell site, the Commission, by subsequent Order, shall compel them to submit a list, with supporting technical information and evidence, of specific potential and suitable alternative sites where the proposed tower might be located, other than the proposed site outlined in the application.

IT IS THEREFORE ORDERED that:

1. Within 10 days of the date of this Order, Tracy Sullivan Sears and the Edith Sullivan Life Estate shall state, in writing:

a. Whether they intend to remain as Intervenors in this case.

b. If the Intervenors intend to remain in this proceeding, they shall state, in writing, whether they intend to appear at a hearing on the application and whether they intend to present evidence in opposition to the proposed cell site.

2. The Intervenors shall file an original and 5 copies of their statements with the Commission and shall serve a copy of their statements to the Applicant.
