REQUEST:

- 1. Refer to the response to the Commission Staff's February 29, 2008 Data Request ("Staff Supplemental Request") in Case No. 2007-00369, Item 3(c). Was the scheduled March 20, 2008 meeting to further develop the program details of the Home Energy Assistant ("HEA") program held?
- a. If yes, provide any additional program details that were finalized at this meeting.
- b. If no, indicate when Duke Kentucky anticipates the additional program details will be addressed by the Collaborative members.

RESPONSE:

- a. Yes. The initial meeting with Northern Kentucky Community Action Commission (NKCAC) occurred on March 20, 2008. Approaches were discussed, but not finalized. We agreed to review procedures from the 2006 program and to look for ways to simplify and streamline the process for the 2008 program.
- b. Further meetings will be held with NKCAC regarding program details. It is anticipated that another Kentucky Collaborative meeting will occur within the next 30-60 days.

REQUEST:

Refer to response to the Staff Supplemental Request in Case No. 2007-00369, Item 5.

- a. Provide the bill credit formula previously utilized by the Northern Kentucky Communicaty Action Commission ("CAC") with the initial HEA program.
- b. Explain in detail why the bill credit formula CAC plans to use in conjunction with the proposed HEA program was not provided with the response.
- c. Provide the bill credit formula to be utilized in conjunction with the proposed HEA, as originally requested. If not available, indicate when this formula can be provided.

RESPONSE:

a. The bill credit formula previously used by the NKCAC for the HEA program was similar to the LIHEAP formula. After verifying income and appropriate poverty level, the customer's eligible credit amount was determined. Please see formula chart below.

Poverty Level	Electric	Natural Gas
00 – 33%	\$24	\$28
34 – 65%	\$41	\$46
66 – 98%	\$53	\$60
99 – 130%	\$55	\$63

b. The bill credit formula the NKCAC plans to use in conjunction with the proposed HEA program was not provided with the response because the credit calculation is being designed as part of the program details.

c. We plan to have the formula completed within the next 30-60 days as part of the program design.
