## ANSWER AND MOTION FOR INFORMAL CONFERENCE OF KENTUCKY UTILITIES COMPANY

#### **ANSWER**

In accordance with the Kentucky Public Service Commission's ("Commission") Order of April 22, 2008 in the above-captioned proceeding, Kentucky Utilities Company ("KU" or the "Company") respectfully submits this Answer to the Complaint of Russell D. Alred filed on April 16, 2008. In support of its Answer, and in response to the specific averments contained in said Complaint, KU states as follows:

1. KU admits the allegations contained in paragraph (a) of the Complaint, on information and belief.

2. With regard to the allegations contained in paragraph (b) of the Complaint, KU states that its primary business address is One Quality Street; Lexington, Kentucky 40507.

3. With regard to the allegations contained in paragraph (c) of the Complaint, KU states as follows:

(a) KU denies the statement that "KU has unlawfully billed and required me& companies I own to pay a "Fuel Adjustment Clause" in violation of existing law."

(b) KU denies the averment that "KU cannot charge me or any other customer this charge."

(c) KU admits the statement that "KU should only be allowed to bill customers authorized charges," and further states that it does so.

(d) To the extent that there are additional averments contained in the wherefore clause following paragraph (c) of the Complaint, KU denies those allegations

4. KU denies all allegations contained in the Complaint which are not expressly admitted in the foregoing paragraphs of this Answer.

### **First Affirmative Defense**

The Complaint, or parts of it, fails to set forth any claim upon which relief can be granted by this Commission and, therefore should be dismissed.

#### Second Affirmative Defense

KU's fuel adjustment surcharge is lawfully imposed pursuant to 807 KAR 5:056 (eff. 4-7-82) Fuel Adjustment Clause, which was promulgated twenty-six years ago by the Commission pursuant to KRS 278.030(1). That regulation expressly provides that electric utilities operating in the Commonwealth may immediately reflect changes, increases or decreases, in fuel costs pursuant to such a surcharge, subject to retrospective six-month and two-year reviews by the Commission. The regulation further provides that the surcharge be calculated pursuant to a specified formula, and that it reflect the actual cost of fuel incurred to produce electricity only. The surcharge does not include any profit to the electric utility. KU's fuel adjustment surcharge is proper and lawful; has been subject to full and continuous Commission review and oversight; is calculated pursuant to the formula specified in the regulation; reflects KU's cost of fuel to produce electricity; and does not include any profit to KU.

#### **Third Affirmative Defense**

KRS 278.160 requires each utility to file its tariff with the Commission, and prohibits any person from receiving utility service "for a compensation greater or less than" the compensation prescribed in the tariff. Pursuant to KRS 278.160, KU has a tariff on file with the Commission, prescribing the compensation to be charged to its customers, including Complainant. KU's fuel adjustment surcharge appears at pages 70 and 70.1 of its Tariff, which provides, at 70, that such surcharge is a "mandatory rider to all electric rate schedules." Consequently, the law prohibits Complainant from receiving electric service from KU without payment of the surcharge.

#### Fourth Affirmative Defense

Complainant has neither suffered damage nor been injured in any way as a result of his payment of this surcharge, as the surcharge is imposed in return for the cost of fuel necessary to produce the electricity he, as a customer, has requested.

WHEREFORE, for all of the reasons set forth above, Kentucky Utilities Company respectfully requests:

1. An opportunity to conduct discovery, file written testimony and other forms of evidence and a full evidentiary hearing;

2. That following a full evidentiary hearing, the Commission determine that KU has lawfully billed the customer for charges through its fuel adjustment clause;

3. That the Complaint be dismissed with prejudice, and

4. That KU be afforded any and all other relief to which it may be entitled.
