## ORDER

On November 20, 2000, in Case No. 2000-00158,<sup>1</sup> the Commission approved rates for Burkesville Gas Company, Inc. ("Burkesville") and provided for their further adjustment on a quarterly basis in accordance with Burkeville's gas cost adjustment ("GCA") clause.

On May 2, 2008, Burkesville filed its proposed GCA to be effective June 1, 2008.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Burkesville's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Burkesville's proposed expected gas cost ("EGC") is \$15.4317 per Mcf, which is \$2.9053 per Mcf more than the prior EGC of \$12.5264.
  - 3. Burkesville's notice sets out no refund adjustment.
- 4. Burkesville's notice sets out a current actual cost adjustment ("ACA") of (\$.7829) per Mcf. Burkesville's notice sets out a total ACA of (\$3.0139) per Mcf.

Burkesville carried forward an incorrect previous quarter ACA in its filing.<sup>2</sup> Correcting for this produces a total ACA of (\$3.0140) per Mcf, which is a decrease of \$.7829 per Mcf from the previous total ACA.

- 5. Burkesville's GCA is \$12.4177 per Mcf, which is \$2.1224 per Mcf more than the previous rate of \$10.2953.
- 6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Burkesville on and after June 1, 2008.

#### IT IS THEREFORE ORDERED that:

- 1. Burkesville's proposed rates are denied.
- 2. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after June 1, 2008.
- 3. Within 20 days of the date of this Order, Burkesville shall file with the Commission its revised tariffs setting out the rates authorized herein.
