SUBJECT: Alleged Failure of the City of Danville to Comply with

Pursuant to the Commission's August 8, 2008 Order, an informal conference was held at the Commission's offices on August 18, 2008 in Frankfort, Kentucky. Commission Staff met with representatives of the City of Danville ("Danville"), Garrard County Water Association ("Garrard County"), Parksville Water District ("Parksville"), and Lake Village Water Association ("Lake Village"). The list of attendees is attached hereto.

The purpose of the conference was to review the facts and circumstances surrounding the wholesale water rates charged by Danville to Garrard County, Parksville, and Lake Village. Discussed at the conference were how the initial rates to each utility were determined, when they went into effect, when they were changed, and what notice was given prior to the changes.

Following a review of these issues, it was agreed that the parties would compile a joint stipulation of facts prior to a briefing schedule being established. Commission Staff agreed to provide a list of issues to be addressed in the joint stipulation.

There being nothing further to discuss, the conference was adjourned.
