#### ORDER

On September 1, 1999, in Case No. 1999-00155, the Commission approved rates for Johnson County Gas Company, Inc. ("Johnson County") and provided for their further adjustment in accordance with Johnson County's gas cost adjustment ("GCA") clause.<sup>1</sup>

On May 27, 2008, Johnson County filed its proposed GCA to be effective July 1, 2008. Johnson County amended its filing on June 4 and June 6, 2008.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Johnson County's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Johnson County proposes an expected gas cost ("EGC") of \$9.8973, which is \$.0978 per Mcf more than the previously approved EGC of \$9.7995.
  - 3. Johnson County's notice sets out no refund adjustment.
- 4. Johnson County's notice sets out a current quarter actual adjustment ("AA") of (\$.2934) per Mcf for the period February 2008 through April 2008. Johnson

County's total AA is (\$3.4292) per Mcf, which is \$.2934 per Mcf less than the previous total AA.

- 5. Johnson County's notice sets out a current quarter balancing adjustment ("BA") of \$.2744 per Mcf. However, Johnson County calculated the BA as if it were an under-collection, when, in fact, it was an over-collection. Correcting for this error produces a current quarter BA of (\$.2744) per Mcf. Johnson County's total BA is (\$.3126) per Mcf, which is \$.2744 per Mcf less than the previous total BA.
- 6. Johnson County's gas cost recovery rate is \$6.1555 per Mcf, which is \$.47 per Mcf less than the previous rate of \$6.6255.
- 7. Johnson County's adjustment in rates is fair, just, and reasonable, and should be approved for billing for service rendered by Johnson County on and after July 1, 2008.

#### IT IS THEREFORE ORDERED that:

- 1. Johnson County's proposed rates are denied.
- 2. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after July 1, 2008.
- 3. Within 20 days of the date of this Order, Johnson County shall file with the Commission its revised tariffs setting out the rates approved herein.
