

### <u>ORDER</u>

On July 15, 2008, Complainant filed a letter addressed to the Commission advising that the parties had agreed to settle this case. Complainant has agreed to pay the outstanding amount of \$200, which reflects Duke Energy Kentucky, Inc.'s ("Duke") recalculation of Complainant's un-metered consumption for the period from September 25, 2007 through December 19, 2007.<sup>1</sup> In exchange, Duke has agreed to note on Complainant's account that he has an alternative source of heating and that his gas usage may be low due to his use of a wood-burning stove.

The Commission, having reviewed the record and being otherwise sufficiently advised, finds that the settlement is reasonable.
