FIRST DATA REQUEST OF COMMISSION STAFF
TO JIM DEVERS

Complainant, Jim Devers, pursuant to 807 KAR 5:001, is to file with the Commission the original and 6 copies of the following information, with a copy to all parties of record. The information requested herein is due on or before August 1, 2008. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Complainant shall make timely amendment to any prior responses if he obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any requests to which

Complainant fails or refuses to furnish all or part of the requested information, he shall provide a written explanation of the specific grounds for his failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request.


1. Refer to the paragraph on page 2 of the complaint form. Explain the statement “. . . and bill adjusted. (70.00 – 90.00)”

2. Refer to Complainant’s unsigned letter dated April 15, 2008, which was attached to the complaint.

a. In paragraph 2, the letter provides that the thermostat was “set on 77 [degrees] for the summer.” Provide the range of dates that this occurred.

b. To the best of Complainant’s knowledge, was the thermostat functioning properly?

c. In paragraph 4, Complainant states, “I understand their bills are quite normal.” Explain this statement and describe the information that provided the basis for making this claim.
