PREHEARING STATEMENT OF WINDSTREAM KENTUCKY EAST LLC OUTLINING ISSUES TO BE ADDRESSED

Windstream Kentucky East, LLC ("Windstream") submits the following Prehearing Statement outlining issues to be addressed as directed by the July 11, 2008 Order of the Kentucky Public Service Commission ("Commission") in this proceeding.

Windstream filed a prehearing statement in this matter on July 3, 2008 – and Windstream adopts that Prehearing Statement as a part of the filing made herein.

From Windstream's perspective, there is one service issue and one rate issue to be addressed at the hearing. These are:

SERVICE ISSUE: Whether the Commission should order the immediate re-routing of the traffic from Brandenburg Telephone Company ("Brandenburg") to MCImetro Access Transmission Services, LLC d/b/a Verizon Access ("Verizon"), and off of Windstream's network, because the traffic is non-tariffed, unauthorized and in violation of established routing protocol procedures.

RATE ISSUE: Whether, and to what extent, the Commission should direct Brandenburg and/or Verizon to pay compensation to Windstream for the past use of Windstream's facilities in the routing of traffic from Brandenburg to Verizon.
