ORDER

Cannonsburg Water District ("Cannonsburg") has proposed revisions to its rate schedules to permit discounted water service to its employees and members of its Board of Commissioners.¹ The Commission has previously rejected similar proposals for such service as unreasonable since water districts "have no shareholders to which the foregone revenue can be charged."² Unlike an investor-owned utility whose shareholders assume the cost of any free or reduced rate service, we have reasoned, a water district's ratepayers bear the cost of such service. In light of these decisions, the Commission finds that additional proceedings are necessary to determine the reasonableness and lawfulness of the proposed revision.

On May 23, 2008, Cannonsburg Water District submitted revised tariff sheets that contained its proposed reduced rate. It proposes to place these revisions into effect on June 22, 2008.

IT IS THEREFORE ORDERED that:

- 1. This proceeding is established to investigate the reasonableness of the proposed rate schedule revisions.
- 2. Cannonsburg's proposed reduced rate for water district commissioners and employees is suspended five months from June 22, 2008 up to and including November 21, 2008.
- 3. Within 20 days of the date of this Order, Cannonsburg shall show cause in writing to the Commission why the proposed rate schedule is reasonable and should not be denied for the reasons set forth above.
