The following and the attached are in response to your letter of May 28, 2008, concerning the increase of the City of Nicholasville's Wholesale Water Rates (volume charge only) in response the recently enacted withdrawal fees increase on the part of the Kentucky River Authority. As you may know, mainstem withdrawers were sent a letter by the Authority, dated January 3, 2008, in which the Executive Director indicated that by state law the City could pass the withdrawal fee increase on to its regulated customers without the action normally required by the Public Service Commission.

AN ORDINANCE OF THE CITY OF NICHOLASVILLE, AMENDING SECTION 23-22 (ORDINANCE 085-1994) WATER RATES.

WHEREAS, the City of Nicholasville provides wholesale water service to certain customers under contractual terms that provide for the City to be able to periodically adjust the rates charged to said customers in order to adequately recover the costs of providing water service to said customers;



ORDINANCE 698-2008

AN ORDINANCE OF THE CITY OF NICHOLASVILLE, AMENDING SECTION 23-21 WATER RATES.

WHEREAS, the City of Nicholasville provides retail water service to customers both inside and outside the corporate limits, to the Spears Water Service District (formerly known as the service territory of the Spears Water Company, Inc.) and wholesale water service to two rural water districts;

WHEREAS, the Kentucky River Authority has raised the Tier II withdrawal fee from \$.016 per one thousand gallons to \$.06 per one thousand gallons, effective April 1, 2008;

WHEREAS, the Board of Commission of the City of Nicholasville in the exercise of its fiduciary duties and responsibilities must now, in consideration of the above withdrawal fee increase, adjust the volumetric water rates charged to customers other than the Spears Water Service District;

Gentlemen:

Jessamine County Water District No. 1 and Jessamine-South Elkhorn Water. District have advised the Public Service Commission that the City of Nicholasville ("Nicholasville") has or will shortly increase its rate for wholesale water service.

In Simpson County Water District v. City of Franklin, 872 S.W.2d 460 (Ky. 1994), the Kentucky Supreme Court held that the Public Service Commission has jurisdiction over contracts between municipal utilities and public utilities and that changes in any rate that a municipal utility assesses a public utility for wholesale utility service must be approved by the Public Service Commission. Pursuant to the Simpson County Water District decision, the Public Service Commission in Administrative Case No. 351 directed that "[a]ny municipal utility wishing to change or revise a contract or rate for wholesale utility service to a public utility shall, no later than 30 days prior to the effective date of the revision, file with the Commission the revised contract and rate schedule." A copy of the Simpson County Water District decision and the Public Service Commission the revised contract and rate schedule." A copy of the Simpson County Water District decision and the Public Service Commission Sorder are enclosed.

Consistent with KRS 278.160 and the Public Service Commission's Order in Administrative Case No. 351, contracts and rate schedules filed with the Public Service Commission shall control the rates and conditions of service of the parties. Changes to those currently on file with the Public Service Commission shall be made in accordance with KRS 278.180 and Administrative Regulation 807 KAR 5:011. Until such changes are approved by the Commission, the prior contracts and rate schedules remain in effect.

The Public Service Commission has not approved any adjustment in Nicholasville's wholesale water service rate (including any additional fee or charge related to withdrawal fees that the Kentucky River Authority assesses). Therefore,

Nicholasville may bill Jessamine County Water District No. 1 and Jessamine-South Elkhorn Water District only at the rates contained in the most recent rate schedule that Nicholasville has filed with the Commission. Until Nicholasville files its proposed revisions with and obtains the approval of the Public Service Commission, it may not charge Jessamine County Water District No. 1 and Jessamine-South Elkhorn Water District a rate that differs from that rate schedule. Furthermore, if Nicholasville is currently charging a rate that differs from those on file with the Public Service Commission, it must either refund the additional charges collected or credit that amount to the wholesale customer's account. I respectfully request that Nicholasville advise the Public Service Commission within 10 days of the date of this letter of the action that it intends to take to resolve this situation.

For your reference, I am enclosing the Public Service Commission's letter of October 16, 2007, which contains detailed guidance on the procedures that a municipal utility must follow when changing its rates for utility service to public utilities.
