RE: Rate Cases Kentucky Utilities Company Louisville Gas and Electric Company

Pursuant to the request of Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (jointly "the Applicants"),¹ a telephone conference was held on September 3, 2008. The Applicants requested the conference in order to obtain clarification of certain data requests of Commission Staff ("Staff") in its Second Data Requests issued August 27, 2008, in the above-referenced cases. Participating in the call were representatives from KU, LG&E, Kentucky Industrial Utility Customers, Inc., The Kroger Company, Community Action Kentucky, Inc., Community Action Council for Lexington-Fayette, Bourbon, Harrison, and Nicholas Counties, Inc., Office of the Attorney General, Association of Community Ministries, People Organized and Working for Energy Reform, and Lexington-Fayette Urban County Government.

KU sought clarification of the requests for information in Item Nos. 90 and 92. LG&E sought clarification of the requests for information in Item Nos. 75 and 76. These data requests concerned the Applicants' depreciation expense. With respect to Item Nos. 75 and 90, Staff explained that its intent was to obtain calculations from KU and LG&E which would separate the impact of the proposed changes in depreciation rates from the annualization impact of changes in plant balances that occurred during the test year. The Applicants' indicated they could provide information responsive to the requests, but that they could not provide it in the exact format requested by Staff.

Staff explained the purpose of Item Nos. 76 and 92 was to have the Applicants compare and contrast their current use of the average service life method with their proposed equal life group approach and separately identify post-1995 ECR assets and ARO assets. The Applicants stated that ECR assets are recorded by specific project, but not by specific plant accounts in the format which Staff had requested. Staff indicated that amounts based upon project totals would be satisfactory responses to these data request items.

¹ KU and LG&E sent an e-mail to the parties on September 3, 2008 requesting the telephone conference. A copy of the e-mail is attached hereto.

KU also sought clarification on Item No. 113(c) and (d) concerning the subject of IT contract costs. The information that Staff expected to obtain from Item No. 113(c) was the annual cost of each IT contract during the test period and for the 12 months immediately preceding the test period. Regarding Item No. 113(d), Staff is seeking to obtain information concerning test year expenses for IT contracts that would go through the prepaid accounts.

Lastly, the Applicants stated that they will be filing written, formal objections to Staff's Second Data Requests: Item Nos. 29 (LG&E); 30(a) and (b) (LG&E); 102 (LG&E); and 125 (KU).

There being no further questions, the telephone conference was adjourned.
