O R D E R

On July 3, 2008, Classic Construction, Inc. ("Classic Construction") and Coolbrook Utilities, LLC ("Coolbrook") (collectively "Joint Applicants") jointly applied for approval of the transfer of the wastewater treatment plant and collection system serving the Coolbrook Subdivision in Franklin County, Kentucky, from Classic Construction to Coolbrook. Classic Construction, a Kentucky corporation that owns and operates facilities that provide sewer service to 437 single-family residences, 4 duplexes, and 1 commercial entity, is a utility subject to Commission jurisdiction.<sup>1</sup> KRS 278.020(5) and (6) require prior Commission approval of the proposed transfer and acquisition. KRS 278.020(6) provides that the Commission approve or deny the proposed application within 60 days of filing, September 1, 2008, unless it is necessary, for good cause, to extend the application for an additional 60 days. Based upon the need for a detailed review of this application, the Commission finds that additional time is required.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in Appendix A to this Order shall be followed in this proceeding.

2. The 60-day time limit for review of the pending application shall be extended for an additional 60 days, pursuant to KRS 278.020(6).

3. All parties to this proceeding shall file the information requested by Commission Staff no later than the dates set forth in Appendix A.

4. Any party wishing a hearing or informal conference in this matter shall file a written request with the Commission on or before September 10, 2008.

5. a. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided, with copies to all parties of record and 6 copies to the Commission.

b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

c. Any party shall make timely amendment to any prior responses if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

d. For any requests to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.


