<u>ORDER</u>

On August 7, 2008, Garrard County Water Association, Inc. ("Garrard") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Garrard purchases water from the city of Berea ("Berea"), city of Danville ("Danville") and city of Lancaster ("Lancaster").

2. Berea notified Garrard that, effective with its September 10, 2008 billing, the wholesale rate would increase from \$1.95 per 1,000 gallons to \$2.20 per 1,000 gallons.

3. Garrard proposes a purchased water adjustment factor of \$0.02 per 1,000 gallons.

4. During the 12-month period ending June 2008, Garrard purchased 254,484,600 gallons from Lancaster, 26,488,176 gallons from Berea, and 99,479,139

gallons from Danville and sold 312,046,441 gallons of water during the same time period. The increase in the cost of purchased water is \$6,622.04, resulting in a purchased water adjustment factor of \$0.02 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.02 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Garrard are approved.

2. The purchased water adjustment factor of \$0.02 per 1,000 gallons as calculated in Appendix A, which is attached hereto and incorporated herein, is approved.

3. The rates in Appendix B, which is attached hereto and incorporated herein, are fair, just, and reasonable and are approved for service provided on or after September 10, 2008.

4. Within 20 days of the date of this Order, Garrard shall file with the Commission revised tariff sheets showing the rates approved herein.
