#### ORDER

On August 14, 2008, CoreTel Kentucky, Inc. ("CoreTel Kentucky") requested Commission approval of an interconnection agreement between Southwestern Bell Telephone Company d/b/a AT&T Kansas and CoreTel Kansas. CoreTel Kentucky stated that it was seeking to port-in and adopt this interconnection agreement with BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky"), pursuant to its right under the AT&T Merger Conditions. On September 3, 2008, AT&T Kentucky filed its response to CoreTel Kentucky's request for approval.

Based on an initial review of the pleadings, the Commission finds that additional information is needed in order to properly evaluate CoreTel Kentucky's request and that a procedural schedule should be established in this case.

#### IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in Appendix A, which is attached hereto and incorporated herein, shall be followed.

- 2. Service of any document or pleading shall be made in accordance with 807 KAR 5:001, Section 3(7), and Civil Rule 5.02.
- 3. The parties shall file an original and 5 copies of any documents filed with the Commission.
- 4. The Commission does not look favorably upon motions for continuance.

  Consequently, motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
- 5. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
