In response to Mr. Gatewood's correspondence dated September 30, 2008, in which it was stated that Citipower's application could not be accepted due to the fact that: "Application does not include a billing analysis. At the minimum, the billing analysis needs to show the number of bills rendered and MCF sales volumes by customer class for calendar year 2007."

In our review of the Application, it appeared that a billing analysis was to be submitted only in the event the utility company billed its customers in increments based on the amount of MCFs purchased. Citipower uses a flat rate billing system, with a flat rate for Residential and Commercial, and a flat rate for Industrial and Institutional, regardless of the amount of MCFs purchased. We apologize for any misunderstanding and irrespective of the interpretation, we attach by separate sheet an original and 10 copies of Citipower, LLC's number of invoices rendered in 2007, and the MCF Sales' Volumes.
