

**NOTICE OF REACTIVATION AND AMENDMENT OF APPLICATION
OF NEXUS COMMUNICATIONS, INC.**

Nexus Communications, Inc. ("Nexus"), by counsel, hereby gives notice, in accordance with the Commission's Order of September 29, 2010, that it reactivates and amends its application. The amendment revises and expands Nexus's wireless Lifeline Offering to allow Kentucky Lifeline-eligible subscribers to select from three (3) enhanced monthly service plans.

The revised plans from which Lifeline customers may choose contain the following terms:

1. Two hundred fifty (250) minutes of free airtime each month. Free minutes will automatically be added to each subscriber's prepaid account each month. Minutes are "anytime" minutes and can be used for domestic calls, including local or intrastate/interstate long distance calls. Unused minutes, or Domestic Short Message Service ("SMS") text messaging, will not carry over to the following month if unused. SMS text messaging will be available at a rate of one text message per minute of airtime;
2. One hundred twenty five (125) minutes of free airtime each month. Free minutes will

automatically be added to each subscriber's prepaid account each month. Minutes are "anytime" minutes and can be used for domestic calls, including local or intrastate/interstate long distance calls. Unused minutes/SMS text messaging will carry over to the following month if unused. Domestic SMS text messaging will be available at a rate of one text messages per minute of airtime. International SMS text messaging will be available at a rate of \$0.20 for each international text sent or received;

3. Sixty eight (68) minutes of free airtime each month. Free minutes will automatically be added to each subscriber's prepaid account each month. Minutes are "anytime" minutes and can be used for domestic calls, including local or intrastate/interstate long distance calls. Unused minutes/SMS text messaging carry over to the following month if unused. Domestic SMS text messaging will be available at a rate of two text messages per each minute of airtime. International SMS text messaging will be available at a rate of \$0.20 for each international text sent or received.

Based on the application, as amended, and on the applicable law, Nexus respectfully urges the Commission to take this opportunity to augment the choices available to Kentucky's Lifeline-eligible customers and asks that its request for extended eligible telecommunications carrier status be granted as to both its wireless and wireline operations in the Commonwealth.
