Dear Mr. Sexton:

This is to memorialize the agreement between Big Sandy Rural Electric Cooperative Corporation and Kentucky Power Company regarding the Czar Coal Corporation facility to be located in Floyd and Martin counties, Kentucky. This agreement is made pursuant to KRS 278.018(6) and is expressly subject to the approval of the Kentucky Public Service Commission.

Big Sandy and Kentucky Power agree that Kentucky Power will provide service to the Czar coal mine that is described in Czar's application in P.S.C. Case No. 2009-00134, In the Matter of: Application of Czar Coal Corporation for Authorization to Receive Service From Kentucky Power Company In Big Sandy RECC's Service Territory for the life of the mine. The parties further agree that this agreement is limited solely to the provision of service by Kentucky Power to the Czar Coal facility that is the subject of the application, and nothing in this agreement shall be deemed as entitling Kentucky Power to provide service to any other facility located in whole or in part in Big Sandy's service territory. Big Sandy and Kentucky Power further agree that nothing in this agreement shall be deemed a change in the boundary line between the certified territories of Big Sandy and Kentucky Power.

In reaching this agreement, Big Sandy and Kentucky Power considered the following facts, which they believe would provide a sufficient basis, even in the absence of this agreement, for the Public Service Commission to approve Czar Coal's application pursuant to KRS 278.018(1) based upon the factors set out at KRS 278.017(3):

(1) The proposed mine constitutes a single new, electric-consuming facility located in the adjacent certified territories of Big Sandy and Kentucky Power. Czar Coal has informed Big Sandy and Kentucky Power that approximately 40% of the reserves expected to be mined are located in Kentucky Power's certified territory; the remaining 60% of reserves are located in Big Sandy's certified territory.

- (2) Under the proposal contained in Czar's application, service will be provided by Kentucky Power through the existing Pevler substation located in Kentucky Power's certified territory. The Pevler substation is located on property owned by Czar. Kentucky Power has been providing service in the area since at least the early 1970s. The Pevler substation, which is now owed by Czar, was originally constructed and owned by Kentucky Power in the early 1970s. The substation was purchased from Kentucky Power in 1994 by Czar's predecessor-in-interest, Cumberland River Coal Company.
- (3) Kentucky Power's existing Dewey-Inez 69 kV line is located immediately adjacent to the Pevler substation. Big Sandy's closest distribution facility is located approximately 3.98 miles from the Czar mine.
- (4) Under the proposal described in the Czar application, neither Kentucky Power nor Big Sandy would be required to construct any facilities. Instead, Czar will construct approximately 5,800 feet of line from the existing Czar-owned electrical infrastructure located at Czar's Matrix mine to the proposed Czar mine. Service to this infrastructure and the Matrix mine is provided through the Pevler substation.
- (5) If service were to be provided by Big Sandy, Big Sandy would be required to re-conductor approximately two miles of existing distribution facilities at a projected cost of approximately \$400,000. In addition, Czar would be required to construct approximately 3.98 miles of distribution line, compared to the 5,800 feet of distribution line Czar would required to construct to receive service from Kentucky Power. Czar estimates that the 3.98 miles of distribution line required to receive service from Big Sandy will exceed the cost of the additional 5,800 feet of distribution line required to receive service from Kentucky Power by approximately \$306,000.
- (6) Czar has indicated that the 5,800 feet of distribution line to be constructed by Czar from the Matrix mine to the Czar mine will be constructed on property owned or leased by Czar, that it will be constructed in accordance with the National Electrical Safety Code, and will be removed when the mineable reserves are exhausted. Czar further has indicated that the distribution line will be subject to inspection by the federal Mine Safety and Health Administration.

Big Sandy and Kentucky Power further agreed that nothing in their agreement would be deemed to change the boundary line between the certified territories of Big Sandy and Kentucky Power. As a result, no other customer of Big Sandy Rural Electric Cooperative Corporation or Kentucky Power Company will be affected by Czar's proposal.
