ORDER

On October 19, 2007, in Case No. 2007-00089,¹ the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On June 19, 2009, Delta filed its proposed GCA to be effective July 27, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$6.3072 per Mcf, which is an increase of \$.4267 per Mcf from the previous EGC of \$5.8805 per Mcf.
- 3. Delta's notice sets out no current quarter Refund Adjustment ("RA"), which is no change from the previous total RA.

- 4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of (\$1.5190) per Mcf. Delta's total AA is \$2.8187 per Mcf, which is a decrease of \$.8635 per Mcf from the previous total AA of \$3.6822 per Mcf.
- 5. Delta's notice sets out a Balance Adjustment ("BA") of (\$.0420) per Mcf, which represents an increase of \$.0099 per Mcf from the previous BA of (\$.0519) per Mcf.
- 6. Delta's GCA is \$9.0839 per Mcf, which is a decrease of \$.4269 per Mcf from the previous GCA of \$9.5108 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after July 27, 2009.

IT IS HEREBY ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after July 27, 2009.
- 2. Within 20 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.
