Dear Mr. Hungler, Jr:

On December 23, 2009, a letter was sent to Ridgelea Investments, Inc. informing you that the application of Ridgelea Investments, Inc. was filed as of December 14, 2009. Upon further review of the application, it was discovered that Ridgelea Investments, Inc. had not fully complied with the filing requirements as contained in the ARF application; therefore, Ridgelea Investments, Inc.'s application is deficient and is not accepted as filed.

Section V of the ARF application requires the applicant, if a corporation, to file a certified copy of its articles of incorporation with the application or if said articles have been previously filed, state the style and case number of the prior filing. Since Ridgelea Investment, Inc.'s application contains neither, the letter of no deficiencies dated December 23, 2009 is withdrawn and your application is listed as deficient and will not be processed until the deficiency is cured.

Additionally, during the review of the filing requirement for articles of incorporation, a check was made of the records of the Secretary of State of Kentucky. That check found that Ridgelea Investments, Inc. had been administratively dissolved as of November 3, 2009. A copy of which is attached.

If you decide to proceed with your application and file your corporate articles, you should consider attaching a certificate of reinstatement or certificate of good standing from the Secretary of State of Kentucky. You are reminded that you can not place any adjusted rates into effect until 30 days notice is given to the Commission.
