## <u>ORDER</u>


On June 2, 2010 the Attorney General's office, Rate Intervention Division ("AG"), filed a motion to dismiss these two unconsolidated rate cases filed by Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E"). The basis for the motion to dismiss is a claim that the historic test periods, upon which the rate cases are based, are unreasonable for setting rates due to the pending transfer of ownership of KU and LG&E by way of a sale of their parent holding company, E.ON U.S. LLC, by E.ON U.S. Investments Corp. to PPL Corporation.

The Commission, having considered the motions to dismiss and in recognition of the evidentiary hearings in both cases scheduled to begin on June 8, 2010, HEREBY ORDERS THAT:

1. Any response to the AG's motion to dismiss shall be filed no later than June 4, 2010.

2. Any reply by the AG shall be filed no later than 10:00 a.m. on June 7, 2010.
