## <u>ORDER</u>

The matter is before the Commission upon a joint motion filed by Grayson Rural Electric Cooperative Corporation ("Grayson") and East Kentucky Power Cooperative, Inc. ("EKPC") requesting permission to withdraw Grayson's motion to reopen this rate case. Grayson and EKPC indicate that they entered into a settlement agreement that resolves many of the issues raised by Grayson's motion to reopen and in other proceedings involving Grayson and EKPC.<sup>1</sup> As a result of the settlement, Grayson has agreed to no longer pursue any relief in this matter. Accordingly, Grayson and EKPC request permission for Grayson to withdraw its motion to reopen.

Having reviewed the joint motion and being otherwise sufficiently advised, the Commission finds that by Order entered January 14, 2011, new rates and charges were approved for EKPC, and this case was closed. Grayson was not a party to this rate case, and it had no right to request a rehearing pursuant to KRS 278.400 or to bring an action for review pursuant to KRS 278.410. Based on the joint motion to withdraw, we find good cause to dismiss as moot Grayson's motion to reopen.


