

1) Tapping fee for 3/4 inch meter: \$ 950.00
2) Tapping fee for 1 inch meter: \$1,450.00
The rates contained in this notice are the rates proposed by the Boone County Water District. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for customers other than the rates included in this notice.

The motion shall be submitted to the Public Service Commission, 211 Sower Boulevard, P.O.
