JOINT STATUS REPORT

BellSouth Telecommunications, Inc., d/b/a AT&T Southeast, d/b/a AT&T Kentucky ("AT&T Kentucky"), and BLC Management LLC d/b/a Angles Communications Solutions ("Angles"), LifeConnex Telecom, LLC f/k/a SwifTel LLC ("LifeConnex"), and


dPi Teleconnect, LLC ("dPi") file this joint status report in accordance with the Order entered by the Kentucky Public Service Commission on December 14, 2010. By Order dated July 14, 2010, the Commission granted the Parties' motion to hold the above-captioned matters in abeyance pending the resolution of similar cases pending in other states (Louisiana, South Carolina, North Carolina and Alabama), and required the Parties to submit a progress report by November 1, 2010, which the Parties did.

Since the November 1, 2010, status report, AT&T Kentucky and Budget Prepay, Inc. d/b/a Budget Phone ("Budget Phone") settled Case No. 2010-00025. By Order dated February 11, 2011, the Commission removed that case from abeyance, dismissed it, and removed it from the Commission's docket.

Hearings in similar cases pending in other states were held in Louisiana on November 4 and 5, 2010, in South Carolina on December 17, 2010, in Alabama on January 21, 2011, and a hearing is scheduled in North Carolina for April 15, 2011. The Parties simultaneously filed their initial post-hearing briefs in Louisiana on January 18, 2011. The Parties' simultaneous reply briefs are due in Louisiana on March 1, 2011, their post-hearing briefs are due in South Carolina on March 16, 2011, and the Parties anticipate that their initial briefs will be due in Alabama on April 1, 2011.


Given these developments, the Parties believe it appropriate for the Commission to continue to hold these cases in abeyance pending the resolution of similar pending cases in other states involving the same parties.


