



On July 31, 2012 a representative for BellSouth Telecommunications, Inc. d/b/a AT&T Southeast d/b/a AT&T Kentucky ("AT&T Kentucky") participated via telephone with Commission Staff in an informal conference regarding the above styled cases. A copy of the sign-in sheet of those who participated is attached.

Despite notice being given, no representatives from either BLC Management LLC d/b/a Angles Communications Solutions ("Angles") or Lifeconnex Telecom, LLC f/k/a Swiftel, LLC ("Lifeconnex") appeared at the Commission's offices or appeared by telephone. It was noted that that Lifeconnex and Angles had the same contact listed with the Commission.

Commission Staff stated that it would review the case files to ensure that the proper contact information was utilized when notice of the informal conference was issued. If notice was improperly given, Commission Staff stated it would schedule another informal conference and ensure notice was properly given. AT&T Kentucky stated that it would explore procedural options in the meantime.
