JOINT MOTION FOR EXTENSION OF TIME TO FILE REBUTTAL TESTIMONY

Sprint Communications Co. LP, Sprint Spectrum L.P., Nextel West Corp., and NPCR, Inc, d/b/a Nextel Partners (collectively, "Sprint") and Bellsouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky") jointly move the Commission to grant a one-day extension of time, until September 17, 2010, to file rebuttal testimony.

As grounds for its Motion, and as the Commission is aware, the parties are involved in multiple arbitration proceedings in sister jurisdictions. Rebuttal testimony was due in Georgia on September 15, and Counsels' workload therefore necessitates moving for this extension.
