### ORDER

On February 22, 2010, North McLean County Water District ("North McLean") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. North McLean purchases water from the City of Calhoun Water Works ("Calhoun"), West Daviess County Water District ("West Daviess"), and the City of Livermore ("Livermore").
- 2. Calhoun notified North McLean that it would increase its wholesale water rate effective March 11, 2010. Calhoun's wholesale water rate to North McLean would increase from \$1.90 per 1,000 gallons to \$2.30 per 1,000 gallons. North McLean proposes to increase the water rates to its customers effective March 11, 2010.
- 3. During the 12 months ending January 31, 2009, North McLean purchased a total of 109,929,000 gallons of water from Calhoun, a total of 6,776,500 gallons of water from West Daviess, and a total of 896,000 gallons of water from Livermore and

sold a total of 122,751,900 gallons of water. The increase in the cost of purchased water is \$43,971.60, resulting in a purchased water adjustment of \$0.36 per 1,000 gallons.

4. A purchased water adjustment of \$0.36 per 1,000 gallons is fair, just, and reasonable.

### IT IS HEREBY ORDERED that:

- 1. North McLean's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.36 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after March 11, 2010.
  - 3. The tariff sheets filed by North McLean in the application are approved.
