O R D E R

On March 1, 2010, East Logan Water District ("East Logan") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. East Logan purchases water from the Logan/Todd Regional Water Commission ("Logan/Todd").
2. Logan/Todd notified East Logan that, effective with its March 1, 2010 billing, Logan/Todd's wholesale water rate to East Logan would increase from \$3.31 per 1,000 gallons to \$3.75 per 1,000 gallons. East Logan proposes to increase the water rates to its customers effective March 1, 2010.
3. During the 12 months ending December 31, 2009, East Logan purchased a total of 181,264,600 gallons of water and sold 145,678,900 gallons. The increase in the cost of purchased water is \$79,756.42, resulting in a purchased water adjustment of \$0.55 per 1,000 gallons.



4. The purchased water adjustment of \$0.55 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The rates proposed by East Logan are approved.
2. The purchased water adjustment of \$0.55 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after March 1, 2010.
4. The tariff sheets filed by East Logan are approved as filed.
