ORDER

On March 24, 2010, Sharpsburg Water District ("Sharpsburg") filed its application for Commission approval of proposed water service rates and to eliminate a \$5 monthly surcharge assessed to each of the approximately 150 customers receiving service through the 1996 and 2004 construction projects funded by the Kentucky Department of Agriculture Rural Development. The proposed rates will generate additional annual revenues of \$131,062, a 23.59 percent increase in normalized test year sales from water service rates of \$555,523, and will replace all revenues lost as a result of eliminating the \$5 surcharge. The proposed rates would increase the monthly bill of a customer using 5,000 gallons through a 5/8" x 3/4" meter connection from \$32.15 to \$39.75, a \$7.60 increase.

Commission Staff performed a limited financial review of Sharpsburg's operations and prepared a Staff Report that was issued by Order dated April 23, 2010. Staff's report recommended that the Commission approve the rates requested in Sharpsburg's application as well as the request to eliminate the \$5 surcharge. The Order issuing the report granted all parties 10 days to comment or request an informal conference or hearing. The Commission has not received any comments or requests.

The Commission, after considering the evidence of record and being otherwise sufficiently advised, finds that the rates proposed by Sharpsburg and shown in this Order in the Appendix are fair, just, and reasonable.

IT IS THEREFORE ORDERED that:

- 1. The findings contained in the Staff Report are adopted and incorporated by reference into this Order as if fully set out herein.
- 2. The rates proposed by Sharpsburg and contained in the Appendix to this Order are approved for service rendered by Sharpsburg on and after the date of this Order.
- 3. The \$5 monthly surcharge currently shown in Sharpsburg's tariff is cancelled and shall no longer be effective.
- 4. Within 30 days of the date of this Order, Sharpsburg shall file with the Commission its revised tariffs setting out the rates approved herein and the cancellation of the \$5 surcharge.
