MOTION OF  
JACKSON ENERGY COOPERATIVE CORPORATION  
TO ACCEPT A REVISED DATA RESPONSE AND  
FOR APPROVAL OF TARIFF SHEET CORRECTION

Jackson Energy Cooperative Corporation (“Jackson Energy”) respectfully requests that the Commission accept the filing of a revised data response in this proceeding and to issue an Order approving an increase in the rate for certain street lighting contained in Jackson Energy’s tariff, Sheet No. 15 for Schedule OL – Outdoor Lighting Service. In support of this Motion, Jackson Energy states as follows:

On August 1, 2010, the Commission approved a monthly rate of \$13.42 for street lighting described as 400 Watt HPS 50,000 Lumens, Cobra Head Light – CH3 (“400 Watt HPS – CH3”). Through an inadvertent oversight, this new street lighting rate was not included in the tariff sheet information filed with the Commission on December 9, 2010.<sup>1</sup> Consequently, when the Commission issued its January 14, 2011 Order in this proceeding, the tariff sheets attached to that Order did not include this new street lighting rate. However, when Jackson Energy filed its


new tariff sheets pursuant to the January 14, 2011 Order, it included the 400 Watt HPS – CH3 street light with a rate that reflected the increase applicable to all Jackson Energy street lighting.<sup>2</sup>

Attached to this Motion are two copies of Sheet No. 15 for Schedule OL – Outdoor Lighting Service. The first copy shows the proposed changes in rates by cross-out and italicized inserts. The second copy is a clean version of the same tariff sheet. The increase in the rate for the 400 Watt HPS – CH3 street light reflects a 3.65 percent increase, which is the overall increase determined for street lighting.<sup>3</sup> Jackson Energy believes the application of this percentage for the 400 Watt HPS – CH3 rate is consistent with the approach applied to all its other street lighting rates.

WHEREFORE, Jackson Energy respectfully requests that the Commission accept the attached tariff sheets included with this Motion as a revision to the responses to Items 3 and 4 of the December 9, 2010 filing. Jackson Energy also respectfully requests that the Commission issue an Order that approves the new rate for the 400 Watt HPS – CH3 street light.
