O R D E R

On January 14, 2011, the Commission authorized Jackson Energy Cooperative (“Jackson Energy”) to pass-through an increase from its wholesale supplier, East Kentucky Power Cooperative, Inc.<sup>1</sup> That Order approved rates which were set forth in the tariff sheets attached as an appendix to the Order. The attached tariff sheets were those filed in this proceeding by Jackson Energy on December 9, 2010.

On February 7, 2011, Jackson Energy filed a motion requesting the Commission to accept tariff sheets included with the motion as a revision to the responses to Items 3 and 4 of the December 9, 2010 filing and to approve a new rate for the 400 Watt HPS 50,000 Lumens, Cobra Head Light – CH3 (“400 Watt HPS – CH3”) street light in Jackson Energy’s tariff, Sheet No. 15 for Schedule OL – Outdoor Lighting Service.

Jackson Energy states that on August 1, 2010, the Commission approved a monthly rate of \$13.42 for the 400 Watt HPS – CH3 and that, due to an oversight, the new street lighting rate was not included in the tariff sheet information filed with the Commission on December 9, 2010. Consequently, when the Commission issued its

January 14, 2011 Order in this proceeding, the tariff sheets attached to that Order did not include this new street lighting rate. However, when Jackson Energy filed its new tariff sheets pursuant to the January 14, 2011 Order, it included the 400 Watt HPS – CH3 street light with a rate that reflected the increase applicable to all Jackson Energy street lighting.<sup>2</sup> The rate for the 400 Watt HPS – CH3 street light, as it appears in the revised tariff included with the motion, reflects a 3.65 percent increase, which is the overall increase determined for street lighting.

Based on the motion and a review of Jackson Energy's current tariff and the revised tariffs filed with its motion, the Commission finds that Schedule OL in the appendix to the January 14, 2011 Order should be corrected as discussed above and as reflected in Jackson Energy's 4th Revised Sheet No. 15, attached as an exhibit to Jackson Energy's motion.

IT IS THEREFORE ORDERED that:

1. Jackson Energy's request to accept the attached tariff sheets included in its motion as a revision to the responses to Items 3 and 4 of the December 9, 2010 filing is granted.

2. The appendix to the January 14, 2011 Order is amended to reflect the monthly per-unit rate of \$13.91 for 400 Watt HPS 50,000 Lumens, Cobra Head Light – CH3.

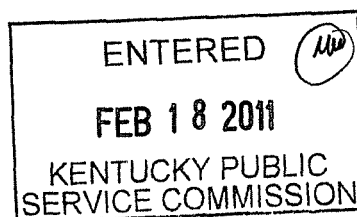

3. All other provisions of the January 14, 2011 Order shall remain in full force and effect.

4. Within 20 days of the date of this Order, Jackson Energy shall file with this Commission its revised tariffs setting out the rates approved herein and stating that they were approved pursuant to this Order.
