COMMISSION STAFF'S FOURTH INFORMATION REQUEST TO NOLIN RURAL ELECTRIC COOPERATIVE CORPORATION

Pursuant to 807 KAR 5:001, Nolin Rural Electric Cooperative Corporation ("Nolin") is to file with the Commission the original and 10 copies of the following information, with a copy to all parties of record. The information requested herein is due within 14 days of the date of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Nolin shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when

made, is now incorrect in any material respect. For any request to which Nolin fails or refuses to furnish all or part of the requested information, Nolin shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request.

1. Refer to page 13 of the rebuttal testimony of Isaac Scott filed on behalf of East Kentucky Power Cooperative, Inc. ("EKPC") on October 15, 2010, in Case No. 2010-00167. Mr. Scott states that Nolin's situation is similar to that of Owen Electric Cooperative, Inc. and Gallatin Steel² in that the amount of EKPC's increase for Rate G is greater than the amount that Nolin has proposed to flow-through to AGC Automotive ("AGC") in this case. In the event the Commission decides that the increase to AGC must be flowed-through based on EKPC's Rate G, additional information is required. With retail rates for AGC calculated using the Rate G rates in EKPC's application, provide revised versions of all exhibits in Nolin's application that will be affected by the
