PETITION FOR FULL INTERVENTION OF THE KROGER CO.

Pursuant to K.R.S. §278.310 and 807 KAR 5:001 Section 3(8), The Kroger Co. ("Kroger") requests that it be granted full intervention in the above captioned proceeding and states in support thereof as follows:

1. Kroger operates over a hundred and ten retail stores and distribution centers throughout the service areas of Louisville Gas & Electric Company ("LG&E") and Kentucky Utilities Company ("KU") (together, the "Utilities") and purchases substantial amounts of electric and gas energy for these facilities from the Utilities. Electric and gas services represent a significant cost of doing business for Kroger, and the operating policies, practices, procedures and philosophy of PPL Corporation as the prospective purchaser of E.ON US LLC and the Utilities is of utmost importance to Kroger. Kroger therefore has a special interest in this proceeding in that the transfer and change of control of the Utilities may have a significant impact on the services furnished by the Utilities to Kroger and the cost thereof. As a large commercial customer of the Utilities, the position of Kroger cannot be adequately represented by

any existing party. Kroger intends to play a constructive role in the Commission's decision making process and its participation will not unduly prejudice any party.
