O R D E R

This matter arises upon the motions for intervention filed by the city of Henderson, Henderson Municipal Power & Light, and Henderson Water Utility ("Petitioners") on August 16, 2010. It appears to the Kentucky State Board on Electric Generation and Transmission Siting ("Siting Board") that these interventions are likely to present issues and develop facts that will assist the Siting Board in fully considering the matter without unduly complicating or disrupting the proceedings. Therefore, the Siting Board will grant the motions for intervention, which are not opposed by the applicant, Southern Indiana Gas & Electric Co. d/b/a Vectren Energy Delivery of Indiana, Inc. ("Vectren").¹

Although each Petitioner is an individual intervenor, based on Siting Board Staff's August 19, 2010 discussion with Petitioners' counsel regarding service, the Siting Board may serve one copy of this Order and any subsequent Siting Board Order,

correspondence, or other document on Petitioners' counsel, as opposed to three copies of each Order or document.

Petitioners also request an evidentiary hearing in this matter. The Siting Board will take Petitioners' request for a full evidentiary hearing under advisement and will issue a subsequent Order ruling on the request for a hearing.

Pursuant to the July 21, 2010 procedural schedule (as revised by the Siting Board's August 9, 2010 Order), the deadline for intervenors to file information requests on Vectren was August 23, 2010, and the deadline for Vectren to respond to intervenor information requests is August 30, 2010. However, Petitioners' August 16, 2010 requests for intervenor status were not granted prior to the August 23, 2010 deadline.

Petitioners filed motions seeking additional time to file their information requests on Vectren. However, Petitioners subsequently filed their information requests on Vectren by the August 23, 2010 deadline. Therefore, the motions for additional time to file information requests are moot and shall be denied.

IT IS THEREFORE ORDERED that:

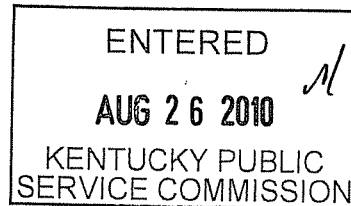
1. The motions of Petitioners to intervene are granted.
2. Each Petitioner shall be entitled to the full rights of a party and shall be served with the Siting Board's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order. Service by the Siting Board of one copy of any Siting Board Order, filed testimony, exhibits, pleadings, correspondence, or any other documents on Petitioners' counsel shall constitute service on all of the Petitioners.

3. If any Petitioner files documents of any kind with the Siting Board in the course of these proceedings, a copy of those documents shall also be served on all other parties of record.


4. The motions of Petitioners for additional time to file their information requests on Vectren and for Vectren to file its responses thereto are denied.

5. All other provisions of the July 21, 2010 procedural schedule, as revised by the Siting Board's August 9, 2010 Order, shall remain in full force and effect.
