O R D E R

This matter arises upon the motion filed by Henderson Water Utility ("HWU") to reschedule the evidentiary hearing previously scheduled to be held on October 13, 2010, at the Frankfort offices of the Kentucky Public Service Commission. HWU's motion also requests that the Kentucky State Board on Electric Generation and Transmission Siting's ("Siting Board") August 31, 2010 procedural schedule be amended to extend the deadlines for the parties to file their witness lists, summaries of witness testimony, and direct testimony.

In support of its motion for additional time, HWU states that the Applicant, Southern Indiana Gas & Electric Co. d/b/a Vectren Energy Delivery of Indiana, Inc. ("Vectren"), "has failed and refused to completely answer data requests served by HWU" and that, without the information which HWU has requested, "it is impossible for HWU to identify those witnesses who will testify on its behalf at the formal evidentiary hearing, to provide brief summaries of their testimony, or to file direct testimony."

HWU filed a motion to compel Vectren to provide the data requested in its information requests regarding the design specifications for the support facilities Vectren proposes to site on its property and the exact location of each of those facilities. Vectren filed its response to the motion to compel on September 20, 2010, in which it explained that it had provided all information in its possession that is responsive to HWU's information request. Vectren notes that "the information contained at Tab 20 of Volume II of the application shows the type and location of proposed support structures, and Tab 5 of Volume I contains detailed engineering diagrams of each of the proposed structures." More specifically, Vectren states that the map at Tab 20 of Volume 2 "shows the proposed location of a lattice tower and three single towers."

Vectren also states that the final determination of the exact location for each support structure and the exact design specifications for each tower or pole will be subject to further engineering studies that will not be done by Vectren unless the Siting Board approves its Application. Vectren states that the support structure diagrams in Tab 5 of Volume 1 of the Application "are typical of those used by the utility industry and represent the best information Vectren currently has available regarding the design specifications of said structures."

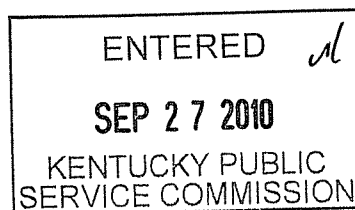
The Siting Board finds that Vectren has substantially complied with HWU's data request. Therefore, the Board will deny HWU's motion to compel. However, the time elapsed during the discovery dispute has made it necessary to extend the deadline for the parties to file their witness lists, summary testimony, and final prehearing testimony in this matter. In its response, Vectren states that it does not oppose an extension of the filing deadline for those items.

The Siting Board finds that the procedural schedule in this matter should be revised to provide sufficient time for the parties to comply with the prehearing filing requirements. The Siting Board also finds that, due to the statutory deadline of November 12, 2010 for the Siting Board to issue its final decision in this matter, pursuant to KRS 278.714(3), HWU's request to reschedule the October 13, 2010 evidentiary hearing in this matter must be denied.


IT IS THEREFORE ORDERED that:

1. The motion of HWU for an extension of time to file witness lists, summaries of witness testimony, and direct testimony is granted.
2. The motion of HWU to reschedule the October 13, 2010 evidentiary hearing is denied.
3. All parties shall comply with the revised procedural schedule attached as an Appendix to this Order.

- Vectren shall publish notice of the formal evidentiary hearing in a newspaper of general circulation in Henderson County and Webster County no later than 09/29/10
