STAFF REPORT

ON

NORTH MARSHALL WATER DISTRICT

CASE NO. 2010-00247

Pursuant to a request by North Marshall Water District ("North Marshall") for Commission Staff ("Staff") assistance with the preparation of an application for an adjustment of water service rates, Staff performed a limited financial review of North Marshall's test-year operations, the calendar year ending December 31, 2009. The scope of Staff's review was limited to obtaining information as to whether the test-year operating revenues and expenses were representative of normal operations. Known and measurable adjustments were made to test-year operations as allowed by 807 KAR 5:001, Section 10(7). Insignificant or immaterial discrepancies were not pursued and are not addressed herein. Upon completion of the review, Staff assisted North Marshall in the development and preparation of an application. North Marshall filed the Application on July 19, 2010.

As stated in the Application, North Marshall's revenue requirement from monthly water service rates is \$1,402,392, requiring a \$266,645, or 23.48 percent,¹ increase over present rate revenue of \$1,135,747.² However, to minimize the potential "rate

This amount should have been stated at \$9,858, the pro forma amount shown on Exhibit E, Page 1. Correction of this error results in a revenue increase of \$306,076, or 26.95 percent. Because North Marshall only requested a 20 percent increase to minimize "rate shock," correction of this error does not impact the requested rates.

shock" felt by its customers, North Marshall sought to increase revenues by only \$227,149, or 20 percent.³ North Marshall requested that the increase be applied to its current monthly water service rates across the board evenly.⁴ The requested rates will increase the monthly bill of a customer using 5,000 gallons through a 5/8" x 3/4" meter connection from \$21.78 to \$26.14, a \$4.36 increase.

After reviewing North Marshall's financial information and Application, Staff finds that:

- North Marshall's proposed adjusted operating statement, as presented in its Application, is reflective of normal operations and should be used to determine North Marshall's revenue requirement;
- 2. It is appropriate to apply the requested increase across the board evenly to all monthly water service rates;
- 3. Although the rates proposed by North Marshall, as shown in Attachment A, will not produce revenues equal to North Marshall's revenue requirement, they will provide enough revenue for North Marshall to meet its long-term debt principal and interest payments, pay all pro forma cash operating expenses, and fund 83 percent⁵ of its pro forma depreciation expense; and

4. The Commission should approve the rates requested by North Marshall.
