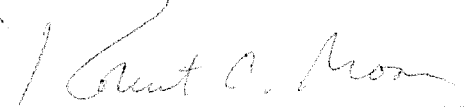
**NOTICE OF FILING BY COOLBROOK UTILITIES, LLC**

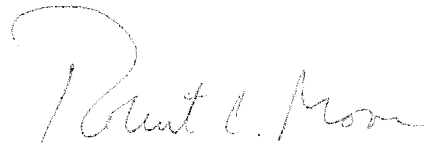
