Pursuant to the Commission's September 7, 2010 Order, on October 14, 2010, representatives of Kentucky Power Company ("Kentucky Power") and Commission Staff met at the Commission's offices to discuss Kentucky Power's responses to the first round of data requests in the current examination of the company's environmental surcharge mechanism.
