## ORDER

Jilapuhn Inc., doing business as Stateside Communications ("Stateside"), applied for authorization to provide telecommunications services within Kentucky. The Commission had previously removed Stateside from its list of authorized telecommunications providers and stricken Stateside's tariff because of Stateside's failure to submit a report of its gross annual operating revenues, as KRS 278.140 requires its annual assessment for the Commission's maintenance.<sup>1</sup>

On April 1, 2010, Stateside filed its petition for reinstatement of its authorization to provide telecommunications service. In a subsequent filing, Stateside stated that it had submitted all required reports and paid all outstanding fees. It acknowledged that it had failed to file the required report of gross operating revenues in 2003 but noted that it had no customers or revenues from Kentucky in 2002 and paid the minimum statutory assessment of \$50. The records of the Department of Revenue confirm this payment

and other Stateside payments for the annual assessment for the Commission's maintenance after its delisting.

Having reviewed the evidence of record and the records of the Department of Revenue, the Commission finds that Stateside should again be authorized to provide telecommunications service in Kentucky.

## IT IS THEREFORE ORDERED that:

- 1. Stateside is authorized to provide telecommunications service in Kentucky upon filing with the Commission a tariff that complies with Commission regulations.
- 2. Within 30 days of the date of this Order, Stateside shall file with the Commission a tariff that complies with Commission regulations.
  - 3. This case is closed and removed from the Commission's docket.
