Dear Mr. and Mrs. Driver,

New Cingular Wireless PCS, LLC has received a copy of your letter dated October 15, 2010 sent to the Kentucky Public Service commission regarding the above application.

Section 706 of the Telecommunications Act of 1996 directed the Federal Communications Commission (FCC) to encourage deployment of advanced telecommunications capability to all Americans on a reasonable and timely basis. The FCC has also furthered the intentions of Congress by repeatedly emphasizing the importance of wireless emergency 911 services for the greater public safety. The daily average of 911 calls made using wireless services has steadily increased with a continuing trend as numbers of wireless subscribers are increasing. Moreover, federal, state and local public safety authorities routinely rely on wireless network infrastructure to deploy wireless communication equipment necessary for essential emergency services and supporting homeland security.

New Cingular Wireless PCS, LLC, as holder of the wireless license in this area, is required by the FCC to adequately provide wireless coverage throughout this license area in a timely

manner. We take this duty seriously and annually spend millions of dollars throughout the Commonwealth of Kentucky in support of this requirement.

On October 12, 2010, Mr. Driver contacted me via telephone expressing an interest in leasing ground space to AT&T Mobility on property you own on Matney Road that is adjacent to the property described in our application. Mr. Driver also had a chance to speak with Richard Elms, of SBA Network Services, whose company is responsible for acquiring the property rights on behalf of AT&T Mobility and who also explained to Mr. Driver the acquisition process.

I trust from these conversations and subsequent communication regarding said interest that you no longer maintain your objection to the proposed tower as indicated in your letter to the Kentucky Public Service Commission. Please submit a letter to the Kentucky Public Service Commission withdrawing your earlier objection.
