

Dear Mr. Duncan:

On August 11, 2011, the Commission established new rates for Center Ridge Water District and directed Center Ridge Water District to refund or credit to its customers all amounts collected for service rendered from April 15, 2011 to August 11, 2011 that were in excess of the approved monthly rate. The Commission further directed that Center Ridge file with the Commission no later than October 25, 2011 a written report of its efforts to refund all monies collected in excess of the approved rate. As of the date of this letter, the Commission has not received the required report.

The Commission requests that Center Ridge Water District provide the required report within 14 days of this letter. Failure to provide the required report may result in the imposition of administrative sanctions against Center Ridge Water District.
