The Kentucky Cable Telecommunications Association ("KCTA") respectfully moves for full intervention in the above-referenced proceeding pursuant to K.R.S. § 278.310 and 807 KAR 5:001, § 3(8). KCTA is a non-profit organization consisting of 118 cable television systems serving the majority of cable customers throughout Kentucky. Many of the 118 members are competitive local exchange carriers affected by any order regarding intrastate switched access rates.

KCTA seeks full intervenor status pursuant to 807 KAR 5:001 § 3 to allow it to fully participate as a party and to be served with documents related to intrastate switched access rates. As the investigation continues and various positions are developed, however, KCTA members may decide to adopt differing positions requiring the KCTA to redefine or limit either its official position or the membership that it represents. KCTA, on behalf of its members, requests that any member may move for intervention in its own name if positions are developed during the investigation that an individual member feels strongly either in support or against.

KCTA pledges to adhere to all Commission rules and procedures applicable to it as a party intervenor. The undersigned attorneys are authorized to represent KCTA in

this proceeding and to take service of all documents. Within five days of the entry of the Order granting intervention, KCTA's counsel shall establish an Electronic Filing Account for this matter.

WHEREFORE, KCTA moves for full intervention in the above proceeding.
