On November 15, Big Rivers Electric Corporation ("Big Rivers") filed its 2010 Integrated Resource Plan ("IRP") with the Public Service Commission. Big Rivers has discovered errors in a two-page table filed as part of the IRP. The table, entitled "Electric Measure Assumptions (Initial Assumptions & Levelized Costs)", is located in Appendix 2-1 (Residential Measure Descriptions, Assumptions, and Sources) of Appendix B (Demand Side Management, Big Rivers Final Potential Study).

As originally filed, the table inadvertently filled the three right-most columns of the table (labeled "Utility Test", "Part. Test", and "RIM Test") with the same value - 1.00. A corrected table is attached hereto. Please replace the original table with this corrected table.
