

SUBJECT: May 3, 2011, Informal Conference

A telephonic informal conference was held on May 3, 2011. A list of those participating is attached as Attachment A to this memorandum. The purpose of the informal conference was to discuss Duke Energy Kentucky, Inc.'s ("Duke Kentucky") proposed Residential Smart Saver Program.

Commission Staff began the conference by requesting introduction of participants and explaining that an informal conference memorandum would be prepared for the case record.

Commission Staff requested clarification of the income level requirement of the new proposed Residential Smart Saver program, which Duke Kentucky provided. Duke Kentucky also agreed to file the additional information presented for the official case record.

Commission Staff also discussed the fact that Duke Kentucky's suspension period was ending May 13, 2011 for their proposed Demand Side Management ("DSM") rates and inquired if Duke Kentucky was planning on implementing the new rates at the end of the suspension period. Duke Kentucky indicated that they would not be putting any new DSM rates into effect at the end of the suspension period.

The Attorney General indicated that he would not be filing comments.

The conference was then adjourned.
