Telephonic Informal Conference of June 16, 2011

On June 16, 2011, a telephonic conference ("TC") was conducted in this case to discuss issues related to the Staff Report ("Report") issued as an attachment to the Commission's May 20, 2011 Order. The TC was attended by representatives of Valley Gas, Inc. ("Valley") and Commission Staff ("Staff"). A copy of the attendance list for the TC is attached hereto.

Staff initiated the TC for the purpose of getting clarification on whether Valley would contest any of the recommendations contained in the Report. While the time for filing comments allowed for in the Order to which the Report was attached had passed, Valley had e-mailed Staff indicating it wished to discuss one of the issues covered in the Report. The issue in question was the compensation of Valley's president.

Valley's representative indicated that it would not be filing comments to contest any of the recommendations in the Report. However, Valley did indicate that it wished to review the level of management compensation paid by similarly sized jurisdictional gas distribution utilities for future reference and requested Staff assistance in this review endeavor. Staff indicated it was agreeable to providing such assistance.
